#### **Principles of Loss Control Audit**

We are working closely with the COR® department and in line with the updates to the newly released National Audit Instrument. We have updated our Principles of Loss Control Audit course to reflect these changes. New to this course is the addition of an instructional manual that participants can use as a reference tool when performing their company's internal audit.

### **Principles of Loss Control**

One of the most significant changes to the Audit instrument is adding a scoring section entitled Procurement and Contract Management. This section deals with selecting contractors or service providers and a company's requirement to include health and safety as an integral part of their activities. The previous audit tool dealt with this subject under the subcontractor's policy. To address these changes, we are in the process of upgrading our Principles of Loss Control manuals. In the interim, we have gathered sample documents you can use for review and building into your program. Please, don't hesitate to contact the Training Department if you want copies of these samples.

### **Confined Space**

Phase II of the Regulatory changes to the New Brunswick Occupational Health and Safety Act and Regulations include significant changes to the Confined Space regulations. The Training Department is working diligently to revise our Confined Space courses to reflect these changes, with June 2023 being the target for completion. The regulatory changes to other NBCSA courses will dictate additional course upgrades. We will continue to provide updates as we work through these changes.

### **Paper vs. Electronic Audit Submissions**

NBCSA has been issuing audit kits via email for the past few years, and we are now requesting audit submissions to be sent electronically. There are several advantages of sending an electronic audit, first and foremost, the environment. We all need to do our part to protect and preserve the environment; one way the COR® Department can do our role is to request fewer paper audit submissions.

Let's face it, shipping paper audit submissions can be expensive, takes time and relies on a third party for delivery. Sending your audit submission at the click of a button eliminates the wait times and guesswork of where your audit submission is and when it will be delivered. Submitting electronically allows you extra time to complete your audit and the COR® department more time to review. Time can be lost when paper submissions received need to be shipped to a contracted NBCSA Auditor. Documentation is an integral part of due diligence, and submitting electronically will help keep original documentation in-house and available should proof ever be required.

In short, electronic audit submissions are both time and cost-efficient. It saves both your company and NBCSA the stress of having your audit received and reviewed within our suggested 21-day timeframe. It also ensures your documentation is never lost in the mail or not returned after an audit, and we all benefit when the environment benefits.
