The Health and Safety Conference organized by WorkSafeNB was a two-day event featuring notable speakers who delivered impactful presentations. The conference began with a compelling talk by Spencer Beach, a burn survivor, safety culture expert, and workplace safety advocate. Beach shared his emotional journey, emphasizing the importance of prioritizing workplace health and safety. Despite facing severe hardships, including addiction and depression, Beach overcame immense challenges after surviving a workplace accident that left him with a mere 5% chance of survival.

The conference concluded with another remarkable speaker, Hayley Wickenheiser, a four-time Olympic gold medalist and member of the Hockey Hall of Fame. Wickenheiser, known as one of the best female hockey players worldwide, has achieved remarkable success with seven world championships, six Olympic appearances, and five Olympic medals. In addition to her sporting achievements, Wickenheiser serves as the assistant general manager of player development for the Toronto Maple Leafs. She is also a community leader, medical doctor, and businesswoman, inspiring audiences to excel in all aspects of their lives.

Overall, the Health and Safety conference by WorkSafeNB featured outstanding speakers such as Spencer Beach and Hayley Wickenheiser, who shared their personal stories and insights to promote a culture of safety and excellence in the workplace.



Annual traffic safety awareness campaign underway



FREDERICTON (GNB) – With construction season now underway, the provincial government and its industry partners are reminding motorists to slow down, heed posted speed limits, and exercise caution when driving in and around construction zones.

“New Brunswick highways are especially busy in the summer months with people travelling across the province,” said Transportation and Infrastructure Minister Jeff Carr. “By following road and speed reduction signs in construction zones, motorists can ensure their own safety as well as that of our workers.”

The annual campaign includes the New Brunswick Road Builders and Heavy Construction Association, WorkSafeNB and the New Brunswick Construction Safety Association.

“Everyone has a role to play when it comes to safety,” said Tom McGinn, executive director of the New Brunswick Road Builders and Heavy Construction Association. “This campaign is an important annual reminder to the travelling public to respect our construction zones and construction workers. By obeying construction signage and reducing their speed, motorists can assure they are not putting someone’s life at risk.”

The campaign will include messages distributed through social media and on the radio.

Each year, hundreds of people work at summer construction projects on provincial roads. For safety reasons, speed limits are lowered in construction zones. Drivers in New Brunswick are reminded if they get caught speeding in highway construction zones they face double the minimum fine.


Tom Coughlan


